The objective of RAS is to provide customers with the most comprehensive mix of products available in the industry, on-time and defect free. RAS works to ensure customer satisfaction through continuous improvement of our processes.

- Reliance Aerospace Solutions controls our documents and records in accordance with AS9120 Rev B/ISO 9001:2015.
- Documents are identified by document number and revision date.
- Records are controlled and maintained to ensure they are readily available and protected from loss, damage and deterioration.
- Record retention is per customer requirement or as follows: Mill and processing certs = 7 years. All other records = 7 years. Certifications are stored in paper and electronic versions. Electronic data is backed up regularly.
- All customer supplied drawings are not kept up to date and require customer flow down upon revision.
- All personnel have been properly trained for their positions and verified for competence. Training records are kept on file for each employee and updated as needed.

Management Responsibility:

Top management has established and endorsed Reliance Aerospace Solutions quality policy statement:

"Reliance Aerospace Solutions (RAS) is committed to providing customers with product sourcing, accurately, and on time. RAS works to ensure customer satisfaction through continuous improvement of our processes. This is achieved through regular review of this policy, and quality objectives for continued suitability."

Records are on file showing management reviewing the quality management system at planned intervals.

Equipment Capability:

RAS does not maintain any production equipment outside of computer hardware and systems to ensure orders are accurately entered and tracked. RAS ensures that this equipment is maintained to prevent loss of data. RAS approved suppliers offer valued added processing services. Our equipment list exceeds 500 various value added pieces of equipment.

Band Saws, High Production Saws, Aluminum Plate Saws, Shears, Plate Burning, Plate Plasma Cutting, Water Jet Cutting, Annealing Furnaces, Lathes. Machining Centers, Modern Tube Cutters, Tube Lasers, Leveling, Slitting, Blanking Lines, Tube Hones, Trepanners,

Product Realization:

- Customer orders are reviewed in accordance with controlled work instructions which provide communication plans and risk assessment.
- All purchase orders specify "right of entry" provisions for our customers and regulatory agencies.
- Suppliers are added to the Approved Suppliers List after they have been through an
 evaluation process and a list of controls has been put into place. Periodic review of
 suppliers is performed to ensure their continued capabilities. All RAS suppliers are
 3rd party certified and apart of the Reliance Steel & Aluminum Co. family of
 companies.
- All incoming shipments are inspected by the RAS approved supplier as RAS does not physically maintain any inventory. No incoming material is released to production unless it conforms to documented material, dimensional specifications, drawings, and/or special test requirements and all inspections and records are approved by the 3rd party certified approved RAS supplier.
- Both company and customer owned product are verified at the time of receipt and stored in approved methods ensuring identification, traceability and proper preservation by the RAS approved supplier.
- Customer supplied resources are stored in a manner to prevent deterioration and damage while in possession of RAS.



Measurement, Analysis and Improvement

- Internal audits are performed at regular intervals by qualified auditors independent of the process being audited. Records are maintained and discussed at management review.
- Documented procedures have been established for inspection and test activities in order to verify that the specified requirements for the product are met throughout its realization process.
- 100% final inspection on all product test reports and mill certifications are performed by qualified personnel and indicated on the documents.
- Non-conforming material is quickly segregated after it has been identified and recorded by the RAS approved supplier. The material remains in a bonding area while the appropriate actions are taken per documented procedures.
- A defined corrective/preventive action process has been established and documented. Records of all corrective/preventive actions are maintained and reflect an effective follow-up to be performed. Continual monitoring of corrective/preventive actions is performed by top management.
